

Skate PassSM Curriculum End User License Agreement

1. This is an agreement between Skate Pass, LLC, a Colorado limited liability company, Licensors, and _____ (School District), Licensee, who is being licensed to use the Skate PassSM curriculum.
2. Licensee acknowledges that this is only a limited, nonexclusive license. Licensors is and remains the owner of all titles, rights, and interests in the Skate PassSM curriculum.
3. This License permits Licensee to teach the Skate PassSM curriculum only at schools in Licensee's school district. Licensee will not make copies of the Skate PassSM beginning, intermediate, and advanced curriculums or instructional DVD or allow copies of the Skate PassSM beginning, intermediate, and advanced curriculums or instructional DVD to be made by others. Licensee will not reproduce, translate, re-publish, or distribute all or any part of the Skate PassSM curriculum.
4. Licensee will not display the Skate PassSM beginning, intermediate, and advanced curriculums or instructional DVD in any manner in any public or private forum without the express prior written authorization of Licensors.
5. Licensee acknowledges that it is Licensee's responsibility to have parents/guardians of students sign Release, Waiver, and Indemnification forms prior to teaching the Skate PassSM curriculum.
6. LICENSOR IS NOT LIABLE TO LICENSEE FOR ANY DAMAGES, INCLUDING COMPENSATORY, SPECIAL, INCIDENTAL, EXEMPLARY, PUNITIVE, OR CONSEQUENTIAL DAMAGES, CONNECTED WITH OR RESULTING FROM THIS LICENSE AGREEMENT OR LICENSEE'S USE OF THE SKATE PASSSM CURRICULUM.
7. Licensee agrees to defend and indemnify Licensors and hold Licensors harmless from all claims, losses, damages, complaints, or expenses connected with or resulting from, but not limited to, Licensee's school and/or business operations and the use of the Skate PassSM curriculum.
8. Licensors has the right to terminate this License Agreement and Licensee's right to use the Skate PassSM curriculum upon any material breach by Licensee.
9. Licensee agrees to return to Licensors (or to destroy all copies of the Skate PassSM curriculums and DVD at the direction of Licensors) upon termination of the License.
10. This License Agreement is the entire and exclusive agreement between Licensors and Licensee regarding the Skate PassSM curriculum. This License Agreement replaces and supersedes all prior negotiations, dealings, and agreements between Licensors and Licensee regarding the Skate PassSM curriculum.
11. This License Agreement is governed by Colorado law and venue and jurisdiction regarding any legal action arising out of this license shall be in the County of Boulder, State of Colorado only.
12. This License Agreement is valid without Licensors's signature. It becomes effective upon the earlier of Licensee's signature or Licensee's receipt of the Skate PassSM curriculum.
